#### Gifts in Your Will

A gift in your will is one of the best ways to create a lasting legacy and to help TPN end domestic violence, and it won't cost you anything now.

Because each individual situation is unique, we encourage all donors to consult with their financial advisor or tax attorney.

The following language may help you and your attorney when drawing up a bequest:

## Gifts by Beneficiary Designation

It's easy to put your bank accounts, retirement funds, savings bonds, and other financial assets to use in ending domestic violence—and it costs nothing now.

By naming TPN as a beneficiary of these assets, you create a lasting impact and directly support our mission of helping domestic violence survivors and building healthy communities. Your gift impacts survivors and becomes part of your personal legacy to the world.

To name TPN as a beneficiary of your retirement plan, contact your bank or i nsurance company to see whether a change of beneficiary form must be completed.

### How to Change a Beneficiary Designation

- Login to your account or request a Change of Beneficiary Form from your custodian (business holding your money or assets.)
- Follow the links to change your beneficiary or fill out the form.
- Be sure to spell the name of our agency: Turning Points Network
- Include our tax identification number: 02-0350899
- Submit your information online or return your Change of Beneficiary Form to your custodian.

## The 1% Difference

A gift of just one percent of your estate to Turning Points Network can be a very meaningful gift; five percent is even more so. One percent of \$500,000 translates into \$5,000. Five percent would be equivalent to \$25,000.

### Gifts That Reduce Your Taxes

You can contribute these generous gifts for others and potentially receive tax benefits to enjoy for yourself.

## QUALIFIED DISTRIBUTIONS

Donate a required IRS distribution directly to TPN through the IRA Charitable Rollover Extension. This type of gift has tax benefits for those required to take a minimum distribution but who do not need the income, allowing the donation without recognizing the transfer as income.

#### **INVESTMENTS**

Stocks, bonds, and mutual funds that have appreciated in value can support our shared vision of a world beyond domestic violence. You get an income tax deduction for the full market value of donated securities that you have owned for more than one year and avoid the capital gains tax on the appreciated value. You can also request a recurring gift from your Donor Advised Fund.

#### **RETIREMENT ASSETS**

A gift from an employee retirement plan, IRA, or tax-sheltered annuity is an excellent way to make a gift to Turning Points Network while shielding you and your heirs from taxes.

#### LIFE INSURANCE

Life insurance is a valuable asset for making a charitable gift without diminishing other investments or assets earmarked for family members.

#### **REAL ESTATE**

Appreciated real estate, such as a home, vacation property, undeveloped land, or commercial property, can be donated to reduce your taxes, protect your assets, and help end domestic violence.
